## 1. Purpose

The Authority wishes to identify and appoint a suitably qualified vendor for Radio-frequency Identification (RFID) stickers and readers.

The Land Transport Authority intends to employ Radio-frequency identification (RFID) technology for registration and detection of all vehicles in Fiji. The main objective of the proposed system is to automate the vehicle registration information system for better on-road vehicle identification.

The proposed concept is for every vehicle to be fitted with RFID tags which will be updated with current information about the vehicle through the LTAs existing IT System during annual registrations.

The LTA will use RF Reading devices during road side checks to read the tag, and automatically validate the owner and corresponding registration details. The LTA will also have static sites throughout the country with mounted RF Readers for vehicle automated vehicle verifications.

Any mismatches detected will automatically trigger alerts. This system can also be used for lost vehicle detection and/or vehicle robbery tracking.

The LTA wishes to obtain proposals from reputable and qualified vendors who have the capacity to supply these devices, integrate it with LTA's existing system and provide back up support when required in accordance to the EOI Speciation's listed in (5) below.

## 2. What to Lodge

We invite expressions of interest to be submitted to the Authority by **15<sup>th</sup> November 2021, 4pm**. For manual submissions, bidders must submit three (3) hard copies in the EOI box placed at LTA - Level 1 Building A Valelevu, Nasinu, Fiji or upload their submission electronically to the submission site - <https://www.tenderlink.com/ltafi/> by the closing date and time.

For manual submissions, the original hard copy must be marked "ORIGINAL" and the remaining two (2) copies must be marked "COPY 1" and "COPY 2", respectively. The original and the copies must include all supporting materials and be well-bound.
